This inclusive approach fostered a dynamic exchange of ideas and insights from individuals with expertise in Pan Africanism and African trade.

The event commenced with captivating performances by talented artists, setting the stage for an engaging and thought-provoking discussion led by the AfCFTA. The central topic of this discussion revolved around the essence of the AfCFTA platform, and the essential steps needed to establish a unified One-Africa Market. Additionally, the participants were provided with valuable background information on the regional progress towards a Pan African One Africa Market, allowing for a comprehensive understanding of the ongoing efforts.

The subsequent panel discussions showcased the active involvement of philanthropists working towards the advancement of Africa.

Panel 1; featured esteemed individuals who have made significant contributions to the continent's development. Silva Otoko, AU Secretary Chief of Staff, represented AfCFTA, Dr. Memory Dube, Head of Regional Integration at the African Development Bank shared invaluable advancement in the creation of the Youth Entrepreneurship Investment Banks in Africa for both financial and non-financial services, as well as the Youth Adapt incubation programs that are labs for entrepreneurial incubation set up by the ADB. Dr. Ify Ogo, Regional Coordinator at the AfCFTA Secretariat (UNDP), shared their insights on the topic. Ms. Leila Ben Ali, a representative from the migration sector, and Dr. Nkosana Moyo from MINDS also brought their valuable perspective on the leaders that Africa needs that are all-encompassing and competent to work the much-needed infrastructure of communication and transport, through cross-border partnerships across the continent.



Panel 2; focused on exploring the impact of the AfCFTA on businesses, infrastructure, and social enterprises, with a particular emphasis on the ICT sector. Young voices took centre stage during this segment, sharing their experiences and knowledge of what works and what doesn't in terms of infrastructure. The panel featured inspiring Ignite Talks by Nandi Mkhwananzi, the founder of Nanloy organic farming and an entrepreneur, and Edith Njange, an African start-up founder from Kenya. These young entrepreneurs provided firsthand accounts of the transformative power of the AfCFTA on their respective ventures.

In addition to the panel discussions, an engaging debate was held among Youth Parliamentarians from SAYOF and the Wits University Student Representative Council, skilfully moderated by Tarisai from APN. The debate involved passionate youth representatives from Tanzania, South Africa, and Namibia, as well as youth representatives from SAYOF and the Acting President and Deputy President from Wits SRC. This spirited exchange of ideas allowed the youth to voice their perspectives on how the AfCFTA could shape Africa's future.

The outcomes of this significant event will play a vital role in incorporating the voices of the youth into the AfCFTA initiative. By actively engaging young minds and considering their perspectives, Africa can build a more inclusive and prosperous future.
